ANNOUNCEMENT

GENERAL REGULATIONS:

Hope Cup 2014 will be conducted in accordance with the ISU Constitution and General Regulations, the ISU Special Regulations for Figure Skating as well as all pertinent ISU Communications for Figure Skating and the classification of the Estonian Skating Union for season 2013/2014.

The results for Basic Novice A and B, Advanced Novice (A), Junior (A) and Senior (A) will be calculated according to latest ISU regulations. Chicks-Cubs (A class) will be calculated according to the Estonian Figure Skating Union Adapted Classification for Youngsters for season 2013/2014.

- The Organizers have the right to split categories if the number of participants requires that.
- The Organizers have the right to combine categories if the number of participants requires.

RESULTS:

The results for (A class) Novice and Junior will be calculated according to ISU judging system using judging panel of 3 judges.

Chicks – Cubs (A Class) will be calculated according Adapted Classification for Youngsters for season 2013/2014 using judging panel of 3 judges.

ENTRIES:

All ISU-Members and Clubs, National Figure Skating Federations associated with ISU are invited to the competition in any category and class. However, the Organizer shall have the right to limit the number of skaters from the invited clubs, and split categories if the number of participants requires that.

ENTRY FEE:

60.- EUR Chicks A - Basic Novice B

65.- EUR Advanced Novice, Junior A and Senior A

Entry fee must be paid upon preliminary registration (i.e. right after you have received a confirmation on participation). We kindly ask the clubs to make one payment for all its participants. **Deadline for payments is 01.04.2014.** You can change one skater for another in any category if it's paid already in period from entries deadline to 24 hours before the drawing. The entire club will not take part in draw in a case of not paid participant.

AWARDING:

The three best-placed competitors in each event will be awarded with a trophy. All competitors will receive a diploma and a present.

JUDGES:

Each participating Club may nominate one, at least international level judge. The organizer will cover the accommodation and compensation for judges. Transportation will be not covered by the organizer.

EXPENCES:

All participants and teams must pay the accommodation and transportation themselves.

MUSIC:

Music must be recorded on CDs and submitted at the time of accreditation. The music medias must be of good quality and labeled clearly with the Competitor's name, Nation, category and the exact music time. Each program must be recorded on a separate disc.

PROTOCOL:

The protocol will be available on organizer website: www.iktartu.ee

ACCOMMODATION:

The Organizers shall not arrange accommodation.

PROTESTS:

Each team has the right to submit protest against the judges' decision. Protests must be submitted to the Referee of the relevant event at the latest immediately after the event. Upon the submission of the protest a protest fee of 30 EUR must be paid. The referee's decision is final. In the new ISU Judging Systems no protests can be filed against the judges (see Rule 123), but against the right determination of the executed element or any calculation error. In the ISU Judging System protest can be submitted in 24 hours after subsegment (e.g. Short Program) and before the awarding ceremony after the final segment (e.g. Free Skating). Protest must be done in a written form to the referee of the relevant segment. Please read ISU Rule 123.

RESPONSABILITY:

In accordance to ISU Constitution, rule 119, all participants act at their own responsibility.

THE CODE OF ETHICS:

All the skaters, coaches, judges, chaperons should follow the ISU com. 1433. Action against this rule conducts behind itself the disqualification of skater.

DRAW:

An electronic draw will take place on April 17th, 2014, starting orders will be published on our website: www.iktartu.ee

There will not be a draw after short programs. Starting order for free programs will be according to inverse of the results of short programs.

Preliminary time schedule will be sent to participants 10 days before the competition and it will available also on our website: www.iktartu.ee
